General Recycling Guidelines

PLACE IN RECYCLING CONTAINER	 ACCEPTABLE	 NOT ACCEPTABLE
<p>PAPER</p> 	<p>Includes newspaper, magazines, junk mail, office paper, cardboard boxes, aseptic cartons to include milk, juice and soup containers, cereal/food boxes and paper egg cartons. Flatten all boxes.</p>	<p>Materials should be free of plastic bags and wrappers. DO NOT include bath tissue, paper towels, photos, laminated paper, or paper coated with food, wax or foil.</p>
<p>PLASTIC</p> 	<p>Plastic containers numbered 1-5 and 7. Caps can be left on empty bottles. Labels do not need to be removed.</p>	<p>Containers should be empty and free of excess liquids and food residue. DO NOT include utensils, plates, toys, plant pots, garden hoses or pools.</p>
<p>METAL</p> 	<p>Includes clean aluminum, tin and steel cans, foil trays and empty aerosol cans. Labels may remain on the containers. Place metal lids inside cans.</p>	<p>Containers should be empty and free of excess liquids and food residue. DO NOT include fire extinguishers, propane and helium gas tanks, utensils, hangers, small appliances, batteries or auto parts.</p>
<p>GLASS</p> 	<p>Rinse glass bottles and jars to include clear, amber, blue and green glass. Labels do not need to be removed.</p>	<p>DO NOT include light bulbs, mirrors, bakeware, ceramics, drinking glasses, window or auto glass.</p>

What About Plastic #6?

Many recycling programs on a national level no longer include #6 PS plastic, known as polystyrene (check with your local hauler). It comes in expanded (fluffy) and rigid (clear) forms. According to

industry experts, #6 PS plastic is not easily recycled because it is mostly air, often coated with food contaminants, and can cost more than other commodities to recycle due to its lightweight nature, lack of competitive markets and high

transportation costs.

However, #6 expanded polystyrene foam products ("styrofoam") may be dropped off at the Winnetka Public Works building at 1390 Willow Road

in Winnetka. Both block-style styrofoam and clean and rinsed foodservice styrofoam are accepted. #6 hard plastic cups and containers are not accepted. For more information, visit villageofwinnetka.org.



Plastic bags and wrappers should be stuffed into one bag and tied closed. Recycle them at your nearest participating grocery or retail store.

Items on the NOT ACCEPTABLE list may contaminate an entire load of recyclables and SHOULD NOT be placed in your recycling cart or bin.
