### TERMS & CONDITIONS

#### APPLICATION

This application and any required additional documentation, including a copy of the original sales receipt which includes the model, price and date of purchase, must be filled out completely and accurately.

Customers are advised to retain a copy of this application and any accompanying documentation submitted to the Village of Winnetka's Water & Electric Department under this program.

Offer open to all Village of Winnetka residential electric customers. This offer is good on purchases of a Smart Thermostat anytime between September 15, 2022 through December 31, 2023, on a first-come first serve basis while energy efficiency funding is available. Funding for the program is being provided by the Village of Winnetka's wholesale power supplier, the Illinois Municipal Electric Agency.

All mail-in rebate requests must be postmarked September 15, 2022 through December 31, 2023. Rebate requests may also be dropped off at the Village of Winnetka's Village Hall (510 Green Bay Road) or emailed to [smarthtmostat@winnetka.org](mailto:smarthtmostat@winnetka.org), "**ATTN: SMART THERMOSTAT REBATE**". The Village of Winnetka's Water & Electric Department will provide confirmation upon the receipt of the application.

Details of this program, including rebate levels, are subject to change or cancellation without prior notice. Residents are encouraged to check the website of their natural gas provider as they may also offer a thermostat rebate.

#### ELIGIBILITY

This offer is **ONLY** valid for Village of Winnetka residential electric customers applying through the 2022-2023 Smart Thermostat Rebate Program only. This offer is **NOT** valid for new construction homes or commercial properties. Equipment must be installed in the Village of Winnetka's service territory.

#### INSTALLATION REQUIREMENTS

Installations must comply with applicable laws and code requirements. The smart thermostat(s) can be customer installed or installed by a qualified contractor.

#### APPROVAL AND VERIFICATION

Prior to any payment of rebates, Village of Winnetka's Water & Electric Department reserves the right to verify that the equipment has been installed.

#### REBATE AMOUNTS

The Village of Winnetka will provide a rebate for up to two (2) new smart thermostats. A credit in the amount of \$100 for each thermostat will be applied to the requestor's utility account. Rebate credit amount will not exceed the purchase price of thermostats. Maximum rebate amount is \$200.

#### PAYMENT

Please allow six (6) weeks for utility credit. Payment processing may take longer if information is missing on the application. Please call 847-716-3558 if you have any questions about your rebate credit.
