3) Approval of Minutes.

Staff asked for the Board's consent to establish June 23 as the testing date and to hold the examination at North Shore Country Day School. The application process will begin later this spring. Commissioner Baumann moved to call for a Patrol Officer exam as requested by Staff. The motion was seconded by Commissioner Woodbury. The motion carried 3-0.
