- (1) Position was unfilled at the time the position budgets were prepared. Compensation represents a budgeted amount which may change when an individual is hired to fill the position based on qualifications, experience, and benefit elections.
- (2) Part-Time Employees are paid on an hourly basis. Projected compensation is based on current work schedule; actual compensation may vary.
- (3) Employee base rate is budgeted to include a merit bonus of 2.9%. Bonuses are discretionary and can range from 0% - 2.9% of current salary.
- (4) Individuals provided Village Vehicles.
- (5) Employee plans to participate in the Village's health insurance opt-out incentive for 2019. Incentive amounts are as follows: \$4,885.14 for waiving single coverage, \$4,885.14 for waiving employee +1 coverage, and \$6,973.65 for waiving family coverage.
- (6) Sworn Police and Firefighters receive Holiday Pay as follows: Sergeants 40 hours at time and a half pay; Officers 40 hours at straight pay; Firefighters, Lieutenants, and Captains 61 hours at time and a half pay.
- (7) Includes Health Stipend, Sick Leave Cashed Out, Fitness Incentive and Firearms Incentive.
- (8) Pursuant to Section 7.3 of the Open Meetings Act. The total amount budgeted is \$15,400,938.
- (9) Social Security wages are subject to caps as established by the federal government. The budget was prepared with an estimated 2018 wage cap of \$128,700, prior to the actual 2019 cap of \$132,900 being announced. Wages will be paid out using the cap in place at the time of payment.
- (10) Actuarially determined amount required for employees. The following categories of payments to employees are not pension eligible: Auto Allowance, Uniforms, and Health Stipend.
Employees contribute the following amounts to the pension plans: IMRF - 4.5%; Police Pension - 9.91%; Fire Pension - 9.455%. Employer contribution rates for the pension plans are: IMRF - 11.75%, Police Pension - 50.92%, and Fire Pension - 66.03%.
- (11) Sum of total compensation plus benefit costs including health insurance, dental insurance, life insurance, Social Security, and pensions. The total amount budgeted is \$23,424,066.
- (12) Vacation Days vary based on years of service. Firefighters' days equal number of 24 hour shifts.
